PRE-REGISTER FOR THE COVID-19 VACCINE AT MONTGOMERY COUNTY OPERATED CLINICS

PREREGISTER

You must preregister to make an appointment. See eligibility groups: <https://www.montgomerycountymd.gov/covid19/vaccine/#priority-groups>. Please pre-register online. If you need help with the form, call 240-777-2982.

MAKE AN APPOINTMENT

When they have doses available, they will contact you to make a vaccine appointment. This may take some time.

They will send you an email or text message with a link for scheduling your appointment, and a list of available clinic dates, locations, and times. The email will come from c19vaccination@montgomerycountymd.gov. Your appointment link will be **just for you**. Do not share it with other people.

GET VACCINATED

All vaccinations are by appointment only — no walk-ups.

SECOND DOSES: No need to preregister for your second dose! About three weeks after you get your first dose, they will contact you for your second dose appointment. The email will come from: c19vaccination@montgomerycountymd.gov.

YOU MAY FEEL SIDE EFFECTS

After you get your shot, you will sit for 15 minutes. You will be in a group with other people who have just gotten their shots. You will be socially distanced. If you have an immediate reaction, their medically trained staff will help you right away!

You may feel pain at your shot site, tired, muscle aches, joint pain, headaches, and/or chills.

If you have an unexpected reaction, report it through the Vaccine Adverse Event Reporting System (VAERS). If you need help with reporting to VAERS, email info@VAERS.org or call 1-800-822-7967.

WHAT DO I DO IF I DO NOT HAVE ACCESS TO A COMPUTER?

If you are eligible to preregister and do not have computer access, ask a family member or friend to help you complete the online form. You can also call the Preregistration Helpline for assistance at **240-777-2982**. Staff are available to callers in English and Spanish. **The Helpline is open seven days a week from 8 a.m. to 6 p.m. This line is for preregistration only.**

If you have general questions about vaccinations and COVID-19, call **240-777-1755**. **If you do not have an email address or a phone that can receive text messages, they will call you when it is your turn to make an appointment.**



WHERE CAN I GET MY VACCINE?

Each county is progressing along their vaccination plan at a different pace based on population size and the availability of the vaccine. Below is a list of the current vaccination sites available in each county.

Please note that any Marylander who's eligible can register for a vaccine at a mass vaccination site. However, for all other vaccination sites, please be sure to ONLY SCHEDULE AN APPOINTMENT IN THE COUNTY IN WHICH YOU LIVE OR WORK. If you schedule an appointment in another county, your appointment will likely be cancelled, or you may be turned away.

 - Residents must pre-register for a vaccine appointment using the pre-registration portal ([link above](#)) or by calling 240-777-2982. Once you have pre-registered, the county will contact you and schedule your appointment as it receives COVID-19 vaccines from the Maryland Department of Health.

FREDERICK COUNTY:

- **Frederick County Health Department** :
 - Frederick County Health Department is currently vaccinating Phases 1A, 1B, and those in the 65-74* age group who live or work in Frederick County.
 - Process for 65-74 Group*: They will start by offering appointments to people born in or before 1947 who have pre-registered through their Vaccine Interest Form. People will be contacted in alphabetical order by first name. Then they will offer appointments to people born in or before 1948, and so on down to 65 years old. Those interested must submit a **vaccine interest form** using the online portal. Once you have pre-registered, the county will contact you and schedule your appointment as it receives COVID-19 vaccines from the Maryland Department of Health.

Improve How Your Mask Protects You

Correct and consistent mask use is a critical step everyone can take to prevent getting and spreading COVID-19. Masks work best when everyone wears them, but not all masks provide the same protection. When choosing a mask, look at how well it is, how well it filters the air, and how many layers it has.

Two important ways to make sure your mask works the best it can.

1. Make sure your mask fits snugly against your face. Gaps can let air with respiratory droplets leak in and out around the edges of the mask.
2. Pick a mask with layers to keep your respiratory droplets in and others' out. A mask with layers will stop more respiratory droplets getting inside your mask or escaping from your mask if you are sick.

DO:

- 2-ways to layer - Use a cloth mask that has multiple layers of fabric. Wear one disposable mask underneath a cloth mask. The second mask should push the edges of the inner mask against your face. Make sure you can see and breathe easily.
- Choose a mask with a Nose Wire - A nose wire is a metal strip along the top of the mask. Nose wires prevent air from leaking out of the top of the mask. Bend the nose wire over your nose to fit close to your face.
- Use a mask fitter or brace over a disposable mask or a cloth mask to prevent air from leaking around the edges of the mask.
- Check that it Fits Snugly over your nose, mouth, and chin - Check for gaps by cupping your hands around the outside edges of the mask. Make sure no air is flowing from the area near your eyes or from the sides of the mask. If the mask has a good fit, you will feel warm air come through the front of the mask and may be able to see the mask material move in and out with each breath.
- Knot and Tuck ear loops of a 3-ply mask - Knot the ear loops of a 3-ply face mask where they join the edge of the mask. Fold and tuck the unneeded material under the edges.
- Dispose face masks and gloves properly - remove it from behind (do not touch the front of mask); **discard immediately in a closed bin; wash hands with alcohol-based hand rub or soap and water.**

DO NOT:

- Combine two disposable masks - Disposable masks are not designed to fit tightly and wearing more than one will not improve fit.
- Combine a KN95 mask with any other mask - Only use one KN95 mask at a time. The KN95 masks filters 95 percent of aerosol particulates and is made from several synthetic material layers and intended to be worn over the mouth and nose.
- **Discard face masks and gloves in the community - This is dangerous because the protective gear could be infected and spread coronavirus if someone picks them up to toss in trash cans.**

Snow Reminders - Snow is here and frustrations can mount during a snow event. Please adhere to the following to avoid any escalations:

1. Park only in a space you cleared. If you expect guests, clear a spot for them. Common decency dictates that you do not use a space that your neighbor cleared.
2. **The County requires all residents to clear sidewalks within 12-hours after snowfall stops.**
3. **Residents are responsible for fully clearing sidewalks in front of their homes, leading up to their homes, steps, cars and parking spaces.**
4. When clearing snow from cars and sidewalks, deposit snow **ONLY** onto common grounds and your own front yards. Do not pile snow into otherwise unoccupied parking spaces or in such a way as to interfere with pedestrian traffic or site distance. ***If you have neighbors that needs assistance, please help where and when you can.***
